Welcome and Introduction

Dani Shaw calls the meeting to order at 8:10 am. Approval of minutes, no changes.

Strategic Plan Update by Dani Shaw

Dani Shaw underlined in the strategic plan that the vision is to ensure everyone has a safe, affordable, and supported home. The mission focuses on coordinating homelessness prevention to make homelessness rare, brief and non-recurring. The primary goals for 2023-2025 are: Housing & Supports, Housing Crisis Response, Diversion & Prevention and Engagement & Collaboration.

Find Help by Alexandra Reed

Alexandra Reed presented CredibleMind, LINKS, Find Help Update. There has been a jump in search of zip codes, specifically Aubrey, due to outreach with an income-based qualifying housing community. About 51% of the searches initiated on Find Help are for housing, followed by food and health. Rent is the top inquiry, then by glasses, then help paying for housing and assistance from food pantries. Help-seekers doubled from February to March.



Mental Health System Model Site Visits Update by Shelby Redondo

Shelby Redondo presented the Mental Health System Model Site Visits Update. They have been looking into different crisis response models from across the state and shared they are regulated by Health and Human Services. (Kerrville, TX) The crisis stabilization unit (CSU) serves high-risk and is a high acuity unit where the stay is up to 14 days. Feedback received from the agency would recommend a more affordable and flexible solution. The extended observation unit (EOU) in McKinney, operated by Life Path Systems is a combination of an EOU, Crisis Respite Unit, and Diversion center. Life Path receives funding from Collin County and are planning an expansion site that is double the size of their current facility. In Denton County, there are an estimated 12 beds at MHMR, and the option of a crisis respite unit. The crisis respite unit is for individuals who are at low risk for harming others and the max stay is 10 days. Mental health diversion is the newest model to be added into the Health and Human Services domain. Tarrant County Commissioners have supported this and have currently built into their criminal justice system and seen this in other communities being piloted. Gary suggested it would be interesting to see the cross-care collaboration team continue as there will be two lenses to take into consideration. One being coming from law enforcement; we want to find people a solution quickly that isn't jail. The other lens is from the mental health perspective, so it will be up to cross-care collaboration to find that balance in priorities to come up with a recommendation for those leadership teams.

Workgroup Updates

Housing:

Terry Widmer highlighted efforts to re-engage members of the cross-care collaborative. They are addressing engagement issues with veterans through case conferencing collaboration. Terry reported the biggest accomplishment is the advancement of the landlord engagement process, acknowledging Sharon Lee.

Data:

Evelyn Sutton reported from the data dashboard key statistics. New data on student homelessness from 5 counties revealed that 2 students in Argyle are now experiencing homelessness while there has been a decrease in student homelessness in McKinney-Vento, Lewisville and Denton Counties from February 2023 to March



2024. March also saw a large increase in inflows, with 20 referrals from Friends of the Family.

Healthcare:

Olivia Mata-Williams reported that the healthcare workgroup is exploring the gaps between hospital discharge for the unsheltered population and hospital discharge. THR has provided preliminary data and is working to isolate it specifically for Denton County. Additionally, Medical City has also come to the table to join collaboration efforts.

Diversion:

Megan Ball reported no major updates but noted an accomplishment with THN in revising the diversion workflow to include grant funding. This revision allows for conciseness when specifying that an individual was diverted by the Barriers Fund and identifies what funding assisted the individual in the diversion.

Cross Care Collaborations:

Megan Ball reported that the presentations at the last meeting went well. Liaisons from MHMR presented their roles within the jail system. To continue the process, the Sheriff County's office completes the intake process.

Backbone Support Update:

Shelby Redondo reported that the Behavioral Health Leadership team has developed a strategic planning committee which will begin at the start of May 2024.

Housing: June 2024

DATA Workgroup: June 2024

CHAIR: STEPHEN COFFEY

OBJECTIVE & GOALS 2023-2025:

Identify ways to integrate data support for other HLT workgroups to advance funding and advocacy efforts

Meeting Summary

The data dashboard has been updated with data up to May 2024. There are currently 525 households actively experiencing homelessness on our Housing Priority List. The 525 total number for May breaks down into:

46 families	30 Veteran households
525 individuals	149 households experiencing chronic homelessness
49 fleeing domestic violence	

Denton County school districts' data was updated in March 2024. The two largest school districts reported the following:

Denton ISD: 481 students (18% decrease from February 23; 587)
Lewisville ISD: 888 students (13% decrease from February 23; 1024)

Housing intervention prioritization breakdown:

Diversion Services: Households (13%; 66)
Rapid Rehousing Intervention: Households (60.3%; 305)
Permanent Supportive Housing Intervention: Households (26.7%; 135)

- Continue to work with agencies and medical providers for healthcare needs assessment
- Continue to identify stakeholders and build membership

Accomplishments

- Addition of representation from hospitals, DFPS, and law enforcement

Concerns

- The gap in available healthcare services for people experiencing homelessness and unmet health needs are a growing concern for agencies.

CROSS CARE COLLABORATION: June 2024

CHAIR(S): MEGAN BALL & LANDON DICKESON

OBJECTIVE & GOALS 2023-2025:

- *Update local Sequential Intercept Model map*
- *Educate key stakeholders on system processes*
- *Create and implement a planning team to coordinate discharge and care for individuals with high rates of crisis service utilization*

Meeting Summary (provide meeting date and items discussed during meeting)

This group is currently in the knowledge-gathering phase, identifying gaps in the current system as it relates to the unhoused population and determining what can be done on a local level to address these gaps. Judge Jahn presented intercepts 1-5 from the judicial interactions, while also bringing to the group's attention that other counties in Texas are investing in a type of model to address the intermediary needs of mental health services (i.e., Extended observation unit, diversion center, respite combination, etc...).

Short Term Action Items

- Continue mapping of Behavioral Health and Housing Systems; current progress is mapping Intercept 1 and 2 to make corrections, update changes, and highlighted gaps.
- Continue identifying organizations at the response systems' primary integration level.

Accomplishments

- Completed review of SIM mapping 0,1,2,3

Concerns

- Understanding the volume of resources to the capacity of each organization
- There is a lack of adequate mental health diversion options for law enforcement
- New legislation that allows law enforcement to transfer responsibility of care


















